#### Section 4. First Aid Measures

<b>Eyes:</b>	Rinse eyes immediately with running water at low pressure. Consult an ophthalmologist.
<b>Skin Contact:</b>	Take off immediately all contaminated clothing. Get medical attention if irritation develops and persists. Wash skin thoroughly with soap and water for several minutes
<b>Inhalation:</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.

#### Section 5. Fire-Fighting Measures

<b>Flammability:</b>	Flammable.
<b>Extinguishing Media:</b>	SUITABLE: Water spray, fog, CO <sub>2</sub> , dry chemical, or alcohol resistant foam NON SUITABLE: Water.
<b>Special Fire-Fighting Procedure:</b>	Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighters protective clothing will only provide limited protection. Wear self-contained breathing apparatus with a full face piece operated in the positive pressure demand mode when fighting fires.
<b>Unusual Fire and Explosion Hazards:</b>	Vapor may travel to source of ignition and flash back. Vapor may settle low or in confined spaces. May produce a floating fire hazard. Static ignition hazard can result from handling and use. Essential and vegetable oils have the potential to self-heat and contribute to spontaneous combustion when present on fabrics. Caution should be exercised in the storage and launder of fabrics exposed to oils.
<b>PPE and Precautions for Firefighters:</b>	Static charges generated by emptying package in or near flammable vapor may cause flash fire. Use water spray to cool unopened containers.

#### Section 6. Accidental Release Measures

<b>Personal Precautions:</b>	Keep unnecessary personnel away. Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.

<b>Environmental Precautions:</b>	Prevent further leakage or spillage if safe to do so. Do not contaminate water. Avoid release to the environment. Retain and dispose of contaminated wash water. Contact local authorities in case of spillage to drain/aquatic environment.
<b>Containment:</b>	Absorb with clay, sand, or other non-combustible material. Prevent entry into waterways, sewers, and confined areas.
<b>Clean Up:</b>	Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. The product is immiscible with water and will spread on the water surface. <b>Large Spills:</b> Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Prevent product from entering drains. Do not allow material to contaminate ground water system. Absorb in vermiculite, dry sand or earth and place into containers. <b>Small Spills:</b> Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste.

<b>Handling Precautions:</b>	Avoid contact with eyes and mucous. Keep container closed. Handle containers with care. Open slowly in order to control possible pressure release. Store in a cool, well-ventilated area.
