### Section 4. First Aid Measures

**Eyes:** Rinse eyes immediately with running water at low pressure. Consult an ophthalmologist.

**Skin Contact:** Take off immediately all contaminated clothing. Wash skin thoroughly with soap and water for 15 minutes. Get medical attention if irritation develops and persists.

**Inhalation:** If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.

**Ingestion in excess:** Call a physician or poison control center immediately. If swallowed, rinse mouth with water (only if the person is conscious). Do not induce vomiting. If vomiting occurs, the head should be kept low so that stomach vomit doesn't enter the lungs.

### Section 5. Fire-Fighting Measures

## Section 6. Accidental Release Measures

<b>Personal Precautions:</b>	Keep unnecessary personnel away. Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.
<b>Environmental Precautions:</b>	Prevent further leakage or spillage if safe to do so. Do not contaminate water. Avoid release to the environment. Retain and dispose of contaminated wash water. Contact local authorities in case of spillage to drain/aquatic environment.
<b>Containment:</b>	Absorb with clay, sand, or other non-combustible material. Prevent entry into waterways, sewers, and confined areas.
<b>Clean Up:</b>	Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. The product is immiscible with water and will spread on the water surface. Small spills can be wiped up with absorbent material (e.g. cloth, fleece). This material and its container must be disposed of as hazardous waste.

<b>Handling Precautions:</b>	Avoid contact with eyes and mucous membranes. Keep container closed. Handle containers with care. Open slowly in order to control possible pressure release. Store in a cool, dry, well-ventilated area.
